## **GRI EQUIVALENCY**



Below is a list of equivalencies for GRI mandatory courses. Some courses have no available qualifying equivalencies.

A <u>maximum of 2</u> GRI mandatory courses may be substituted by way of these equivalencies. It must be noted on the GRI application by typing "Equivalent" in the course completion date column (e.g. Equivalent – 9/3/25).

Course equivalents must be completed prior to the final GRI application deadline on December 19, 2025. Supporting documents for proof of equivalence completion must be included when submitting the GRI application. This may include course completion certificates and MLS reports for experience equivalents.
