Please note that pursuant to the HAR Bylaws (dated 2020), after a one-year term, the First Vice President and the President-elect automatically are elected to the positions of President-elect and President. The Treasurer shall serve a term of two (2) years. The Secretary shall serve a one (1) year term.

The proposed slate will be voted upon by the **Board of Directors of the HAWAII ASSOCIATION OF REALTORS® at their Annual Meeting scheduled for Thursday, December 16, 2021 at 10:00 a.m.**

Pursuant to the HAR Bylaws (dated 2020), Article X – Election of Officers, Section 5, Nomination by Petition, states the following:

*"Except for offices for which election is automatic, additional candidates may be nominated by petition signed by not less than one hundred (100) Members of the HAWAII ASSOCIATION OF REALTORS®, including at least one (1) Member from each of the five (5) REALTOR associations throughout Hawaii,*

*and submitted to the Chief Executive Officer no less than thirty (30) days prior to the date of the annual membership meeting. No candidate shall be nominated for more than one office and each candidate must signify in writing a willingness to serve if elected.”*

- ❖ **Immediate Past President – *Derek Lau*** of Real Estate Specialists (O’ahu – Member of the Honolulu Board of REALTORS®) – President 2021
