- 1. RR301 Rental Agreement

UNFINISHED/NEW BUSINESS

The SFC reviewed the draft from the subcommittee. Discussion was held.

A motion was adopted that the SFC delete the "[] Rental Extension:" in Paragraph 6 on draft RR301 – Rental Agreement for rental extension.

Rationale: Improved clarity in wording of Paragraph 6.

A motion was adopted that the SFC amend draft RR301 – Rental Agreement Paragraph 7 to "Photovoltaic lease or energy expense (see Renewable Energy Act Addendum)".

Rationale: Improved clarity on what Photovoltaic means.

A motion was adopted that the SFC amend draft RR301 – Rental Agreement Paragraph 7 to include "[] Alarm Service".

Rationale: Additional service that tenant may be responsible for.

A motion was adopted that the SFC amend draft RR301 – Rental Agreement Paragraph 9 to state that "Pursuant to Hawaii law, misrepresentation of a service animal may result in civil fines."

Rationale: Improved clarity of Hawaii law.

A motion was adopted that the SFC approve the draft RR301 – Rental Agreement and publish draft form to members for comments.

2. RR201 - Purchase Contract

The SFC reviewed the draft from the subcommittee. Discussion was held.

A motion was adopted that the SFC amend Paragraph G-4 of draft RR201 – Purchase Contract to include provisions about assignment of contract. Purchase Subcommittee will create a draft and present it to SFC.

A motion was adopted that the SFC amend draft RR201 – Purchase Contract Paragraph H-4 to read as follows:
